Release of Liability and Assumption of Risk

Your assumption of risk includes without limitation, your use of any exercise equipment (mechanical or otherwise), the locker room, sidewalk, parking lot, stairs, pool, pool decks, lawn area, children's play area, spa, sauna, tennis courts, lobby area, or any equipment in the Club facility. Member agrees to assume the risk in his or her participation in any activity, class, program, instruction, or Club- sponsored event. You agree on behalf of yourself and any minor child (and all your respective personal representatives, heirs, executors, administrators, agents, and assigns) to release and discharge the Club (and or affiliates, employees, agents, representatives, successors, and assigns) from any and all claim or causes of action (known or unknown) arising out of the negligence of the Club, whether active or passive, or any of its affiliates, employees, agents, representatives, successors, and assigns) This waiver and release of liability includes, without limitation, injuries which may occur as a result of (a) your use or your minor child's use of any exercise equipment of facilities, (b) Club's improper maintenance of any exercise equipment or facilities, (c) the Club's negligent instruction or supervision, including personal training, and (d) you or your minor child's slipping and falling while on the facility or any portion of the premises for any reason, including the Club's negligent inspection of maintenance or its facility. By execution of this agreement, you hereby agree to indemnify and hold harmless the Club and our affiliates, employees, agents, representatives, successors, and assigns from any loss, liability, damage, or cost you or your minor child may incur due to your presence at the Club. You further expressly agree that the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as permitted by the law in the State of California and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
